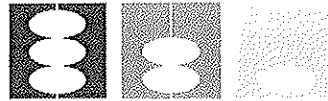

Manual Internet Banking

If your bank doesn't have a quick link banking feature, or you want to make a one-off payment, you can still use internet banking. Log in the same way, and then manually enter all the following details:

Payee name – enter Inland Revenue

Bank Account Number – enter 03-0049-0001100-27

Amount – enter the amount you want to pay from your bank account (eg: \$1,000.00)

Particulars – enter the IRD number of the person or organisation the payment is for. Put a zero in front of eight-digit numbers. (eg: 999-999-999)

Payee code – enter the code for the correct payment type.

eg: INC - Income Tax (includes Provisional Tax)

GST - GST

PAY - PAYE

FBT – Fringe Benefit Tax

Reference - Enter the period end date for this payment - (not the day you're making the payment) (eg: 07/04/2016).
